- Group 3 - CR1 6-10, CR2, CR3.....\$1150.00
- Group 4 - DRY Dock\$695.00
- Group 5 - Personal Watercraft.....\$575.00

THE SEASON BEGINS MAY 1, 2017 AND SHALL EXTEND UNTIL OCTOBER 1, 2017 OR AS WATER LEVEL PERMITS. DUTCH HARBOR, INC. CANNOT BE RESPONSIBLE FOR ADVERSE WEATHER CONDITIONS OR POOR WATER LEVEL.

ALL DOCKAGE FEES ARE DUE IN FULL ON OR BEFORE MARCH 15, 2017.

ALL DOCKERS MUST HAVE INSURANCE. THE FORM ON THE BACK OF THIS AGREEMENT MUST BE FILLED OUT WHEN YOU RETURN THIS FORM. IF WE DO NOT HAVE A CURRENT FORM YOU WILL NOT BE PERMITTED TO LEAVE YOUR BOAT IN YOUR DOCK. **THERE WILL BE NO EXCEPTIONS!!!** DUTCH HARBOR IS NOT RESPONSIBLE IN ANY WAY FOR LOSS OR DAMAGE TO YOUR BOAT DUE TO THEFT, ACTS OF NATURE, FIRE, VANDALISM, OR ANY OTHER CAUSE. THIS INCLUDES EMERGENCY SITUATIONS WHERE AN EMPLOYEE MUST MOVE A BOAT QUICKLY AND DAMAGE COULD OCCUR (I.E. SEVERE STORMS OR OTHER UNUSUAL SITUATIONS).

WE HAVE AT LEAST ONE EMPLOYEE ON THE PREMISE 24 HOURS A DAY DURING THE BOATING SEASON.

DUTCH HARBOR RESERVES THE RIGHT TO RENT ANY DOCK SPACE TO TRANSIENT DOCKERS WHEN THE SPACE IS UNUSED. WE WOULD LIKE TO BE NOTIFIED IF YOUR BOAT WILL BE GONE FOR A PERIOD OF TIME LONGER THAN ONE DAY. DUTCH HARBOR DOES NOT CONDONE FISHING, SWIMMING, OR WADING IN THE DOCK AREA BY DOCKERS, THEIR FAMILIES, OR THEIR GUESTS. THERE IS A 2 MPH SPEED LIMIT WITHIN THE DOCK AREA.

THE DOCK SPACE THAT YOU RENT MUST CONTAIN THE WATERCRAFT THAT IS DESCRIBED ON THIS FORM UNLESS AUTHORIZED BY DUTCH HARBOR. IF THE BOAT DOCKED IN YOUR SLIP CHANGES WE MUST BE NOTIFIED IMMEDIATELY.

WE MUST HAVE NOTICE OF CANCELLATION OF THE DOCK PRIOR TO APRIL 1, 2017 OR YOUR DEPOSIT WILL NOT BE REFUNDED. A 25% CANCELLATION FEE WILL BE DEDUCTED FROM ALL DEPOSITS. **THERE WILL BE NO REFUNDS AFTER APRIL 1, 2017.**
